## NEW HEBRIDES CONDOMINIUM

## JOINT REGULATION

No. 21 of 1975

TO bring into effect the estimates of revenue and expenditure of the Joint Administration for the year 1975.

MADE by the Resident Commissioners under the provisions of Articles 2:2, 5 and 7 of the Anglo-French Protocol of 1914 and of section 5 of the Joint Finance Regulation No· 10 of 1957, after consultation with the Advisory Council and the approval of the Governments of Her Majesty and the French Republic.

Estimates
of revenue
and
expenditure

1. The estimates of revenue and expenditure of the Joint Administration for the year 1975 shall comprise both as to revenue and expenditure the sum of one thousand and fourteen million one hundred and twelve thousand New Hebridean francs (1,014,112,000 FNH) or the equivalent thereof in pounds sterling at the current rate of exchange.

Authorisation of expenditure 2. There shall be issued from General Revenue and other funds of the Joint Administration and applied for the service of the year not exceeding the amount specified in section 1 and the same shall be appropriated as set out in the Schedule.

Authorisation of control of expenditure

3. The Resident Commissioners may jointly authorise the Condominium Ordonnateur and the Condominium Treasurer to control expenditure and revenue, each according to his responsibilities as set out in Joint Standing Order No. 4 of 1957 within the limits fixed by such authorisation and such expenditure shall not exceed the amount specified in section 1.

Citation and commencement

4. This Regulation may be cited as the Joint Appropriation (1975) Regulation No. 21 of 1975 and shall come into operation on the date of its publication in the Condominium Gazette.
