

NEW HEBRIDES CONDOMINIUM

JOINT REGULATION

No. 34 of 1977

TO PROVIDE for Electoral Constituencies and the distribution of seats in the Representative Assembly among such constituencies.

MADE by the Resident Commissioners under the provisions of Article 2 of the Schedule to the Exchange of Notes made at London the 15th September 1977 establishing a Representative Assembly in the New Hebrides.

Constituencies

1. The Representative Assembly in the New Hebrides shall consist of thirty-nine members elected by universal suffrage.

2. (1) The electoral constituencies and the number of seats allocated to each constituency shall be as follows : -

(2) In the island of Efate and in the Municipality of Vila the boundaries of the constituencies shall be those more particularly described and delineated on the maps or plans in the Schedule hereto.

Boundaries of Vila and Luganville.

3. The outer boundaries of the urban constituencies of Vila shall be the boundaries of the Municipality of Vila and the constituency of Luganville shall be the boundaries of the Municipality of Luganville.

Short title and commencement.

4. This Regulation may be cited as the Electoral Constituencies Regulation 1977 and shall come into operation on the date of its publication in the Condominium Gazette.

ANNEXE I

SECTION 3-01-01-1 (SOUTH-WEST EFATE)

From Baffling Point to the La Colle River and, in addition, Vila Island and the Vila Island Native Reserve on the Malapoa peninsula.

SECTION 3-01-01-2 (SOUTH-EAST EFATE)

From the La Colle River and the eastern boundary of the Municipality of Port Vila to the Neslep River and, in addition, the Pango peninsula bounded on the east by the Municipality of Port Vila.

SECTION 3-01-02 (NORTH EFATE)

The islands of Nguna, Pele, Kakoula, Mao, Moso, Lелеppa and Eradaka (Hat Island), and also that portion of Efate Island north of a line joining Baffling Point and the Neslep River.

PORT VILA :

SECTION 3-01-03-1 (TAGABE-MALAPOA)

Consists of the Tagabe area bounded on the north and the east by the municipal boundary, and on the west and south by the sea and the Malapoa Native Reserve respectively, that portion of the Malapoa road situated at Tebakor, a portion of the Mele road, the Condominium road crossing the Lotissement Houdie from west to east and the prolongation of the boundary between the Lotissement Houdie and the Lotissement Ohlen to the municipal boundary,

- the Malapoa area between the sea and the Malapoa Native Reserve,
- the Bourgeois property Kaweriki and the registered properties situated on the southern bank of the Tagabe River and its mouth.

SECTION 3-01-03-2 (ANABROU-TASSIRIKI)

Bounded on the north and the east by Section 3-01-03-1 and the municipal boundary, on the south by the lagoon and Cornwall Street and its prolongation to the lagoon, on the west by Colardeau Avenue, the portion of the Teouma road between the Tassiriki cross-road and the cross-road situated between the French Gendarmerie and the French Hospital, Henri Montfort Street prolonged by Henri Sautot Street and the prolongation of the latter to the sea, Port Vila Bay and the Malapoa Native Reserve respectively.

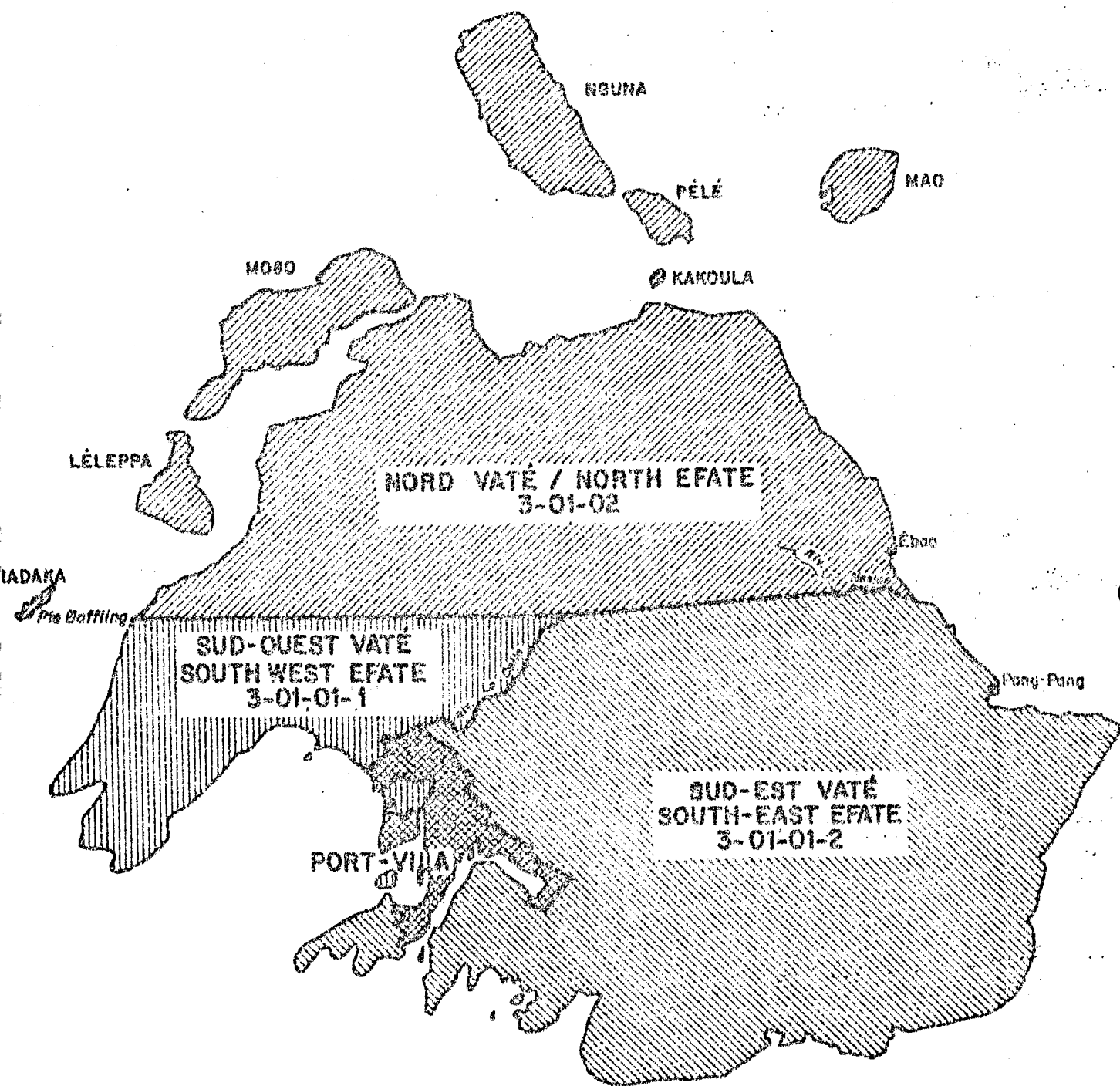
SECTION 3-01-03-3 (CENTRE)

Bounded on the north and the east by section 3-01-03-2, on the south by Artoi Street, followed by the street passing New Hebrides Motors and its prolongation to the sea, on the west by Port Vila Bay, in addition, Iririki islet.

SECTION 3-01-03-4 (NAMBATU-ELLUK)

Bounded on the north by the sections 3-01-03-2 and 3-01-03-3, on the east by the lagoon, on the south and the west by the municipal boundary and Port Vila Bay.
