JOINT REGULATION

No. 27 of 1974

TO AMEND the Joint Price Control Regulation No. 18 of 1974.

MADE by the Resident Commissioners under the provisions of Articles 2:2 and 7 of the Anglo-French Protocol of 1914.

1. Section 3 of the Joint Price Control Regulation No. 18 of 1974 (hereinafter called "the principal Regulation") is hereby amended by the addition of the following paragraph -

"Provided however that police officers of or above the rank of Sergeant in the British Division of the New Hebrides Constabulary and Gendarmes in the French Division of the New Hebrides Constabulary shall, by virtue of their rank and office be entitled to exercise all functions of a Price Inspector upon having made the declaration of secrecy required by section 11. " .

2. Section 8 of the French text of the principal Regulation is hereby amended by deleting the words "avant tout contrôle des prix" and substituting therefor the words: "avant toute réglementation des prix. " .

3. Section 11 of the principal Regulation is hereby amended by the addition of a second paragraph as follows -

"In order to ensure compliance with this section the Controller and Inspectors shall individually enter into an undertaking of secrecy in the form prescribed in Schedule 1. " .

4. The principal Regulation is hereby amended by the addition of a Schedule in the following form -
