TO AMEND the Joint Public Order Regulation N°. 11 of 1974.

MADE by the Resident Commissioners under the provisions of Articles 2:2 and 7 of the Anglo-French Protocol of 1914.

1. Section 1 of the Joint Public Order Regulation N°. 11 of 1974 (hereinafter referred to as "the principal Regulation " is hereby amended by deleting the definition "appropriate authority "and replacing it by the following definition -

> " appropriate authority " means the District Agents of the administrative district concerned and in the case of the absence of a District Agent from his normal place of residence shall be deemed to include an Assistant District Agent in place of such District Agent ; ".

2. Section 1 of the principal Regulation is hereby further amended by deleting the definition " public place " and replacing it by the following definition -

> " public place " means any place whatever, whether publicly or privately owned, which is habitually frequented by the public or to which the public has access, whether on payment or otherwide and shall be deemed to include any place not falling within the foregoing definition at which the public has been invited, whether by individual or general notices, radio announcements or any other medium of information whatever, to attend a meeting. ".
