NEW HEBRIDES CONDOMINIUM

JOINT REGULATION

No. 7 cf 1979

TO PUT INTO EFFECT the Resolution of the Representative Assembly No. 22 of 1978, passed the 15th day of December 1978, to provide for the delegation of powers to the General Committee when the Assembly is in recess.

MADE by the Resident Commissioners under the provisions of Articles 2:2 and 7 of the Anglo-French Protocol of 1914 and Articles 28 (3) and 30 of the Exchange of Notes made at London the 15th day of September 1977 between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the French Republic.

Scheduled Resolution put into effect.

1. The Resclution of the Representative Assembly No. 22 of 1978, set forth in the Schedule is hereby put into effect.

Short title and commencement

2. This Joint Regulation may be cited ax the Representative Assembly (Delegation of Powers) Regulation 1979 and shall come into operation on the date of its publication in the New Hebrides Government Gazette.

RESOLUTION No.22 of 1978

providing for the delegation of powers to the General Committee when the Representative Assembly is in recess.

THE REPRESENTATIVE ASSEMBLY OF THE NEW HEBRIDES

at its sitting on the 15 December, 1978, hereby resolves and decides, in accordance with the Exchange of Notes of the 15th day of September 1977, to adopt the following measures:-

- When the New Hebrides Representative Assembly is in recess it delegates to the General Committee the power to make decisions on draft legislation submitted to it by the Government for the purpose of:
 - (a) effecting a revision of the New Hebrides budget;
 - (b) appraving the articles of Companies of general concern to the New Hebrides and the possible perticipation of the Government in such Companies;
 - (c) establishing funds or statutory bodies arising out of the necessity to create separate accounting procedures for any financial undertakings of the Government and approving the rules relating to the organization and operation of such funds or statutory bodies;
 - (d) authorizing the Government, to raise loans, to request advances from the Treasury, to grant loans or make advances;
 - (e) authorizing the Government to acquire, alienate or exchange real property.
- 2. When the New Hebrides Representative Assembly is in recess, it delegates to the General Committee the power to examine any draft amendment relating to Joint Regulation No. 1 of 1978 and to make recommendations thereon.
- 3. When the New Hebrides Representative Assembly is in recess it delegates to the General Committee the power to control the execution of the Budget and the enforcement of all Resolutions adopted.

- 4. The General Committee is also entitled to approve rules which may be submitted to it by the Government, with respect to the new constitution of the Chamber of Commerce and to quarrying.
- 5. (1) The General Committee shall meet at the request of its Chairman or the Government acting through the Clerk of the Representative Assembly who shall convene all such meetings.
 - (2) Notices of meetings of the General Committee shall give details of the Agenda.
 - (3) When the Government intends tabling draft Resolutions to a meeting of the General Committee these Resolutions shall be attached to the notice convening the meeting at which they are to be tabled.
