

# AUDIT OFFICE AMENDMENT

## WESTERN SAMOA

### Arrangement of Provisions

#### Title

1. Short Title
2. Salary and allowances of Controller and Chief Auditor.

**AN ACT** to amend the Audit Office Ordinance 1961 to provide for the salary, allowance and benefit of the Controller and chief Auditor.

**BE IT ENACTED** by the Legislative Assembly of Western Samoa in Parliament assembled as follows:-

1. **Short Title** -(1) This Act may be cited as the Audit Office Amendment Act 1992/1993 and shall be read together with and deemed part of the Audit Office Ordinance 1961 (hereinafter referred to as the principal Ordinance).

2. **Salary and allowances of Controller and Chief Auditor** -Section 9 of the principal Ordinance is amended by:-

" (a) Repealing subsection (1) and substituting the following subsection:-  
following subsection:-

" (1) There shall be paid to the Controller and Chief Auditor out of the Treasury Fund and be statutory expenditure a salary at the rate of \$33,000 as from the 25th day of November 1991 down to and inclusive of the 12th day of May 1992, and at the rate of \$41,925 a year thereafter."

(b) Repealing paragraph (a) of subsection (2) and substituting the following paragraph :-

"(a) An allowance free of tax at the rate of \$8,000 a year as from the 25th day of November 1991 down to and inclusive of the 12th day of May 1992, and at the rate of \$10,000 a year thereafter."

(c) Inserting immediately after subsection 2 the following new subsection as subsection (2A):-

"(2A) In addition to his salary the Controller and Chief Auditor shall be entitled to such additional benefits as may be determined from time to time by Cabinet, and the provisions of subsection (3) of this section shall apply to such benefits as if they formed part of his salary."

**1. Igoa Puupuu -(1) E mafai ona taua lenei Tulafono o le Tulafono o Teuteuga o le Tulafono o le Ofisa o Suetusi 1992/1993 ma e tatau ona fatauina faatasi ma avea ai o se vaega o le Tulafono o le Ofisa o Suetusi 1961 (e pei ona faasinomia mulimuli ane iinei o le Tulafono autu).**

**2. Totogi ma alauni o le Faatonu ma Suetusi Sili -O le Fuaiupu 9 o le Tulafono autu ua teuteuina i le:-**

" (a) Ia soloia le faafuaiupu (1) ma suaia i le faafuaiupu e faapea:-  
" (1) O le a tatau ona totogiina atu i le Faatonu ma Suetusi Sili mai le Faaputuga-Tupe a le Matagaluega o Tupe ma avea ai ma tupe alu faale-tulafono se totogi fuapauina e \$33,000 e amata mai i le aso 25 o Novema 1991 e oo mai i ma e aofia ai le aso 12 o Me 1992, ma i le totogi fuapauina e \$41,925 i tausaga taitasi e mulimuli mai ai."

**(b) Ia soloia le parakalafa (a) o le faafuaiupu (2) ma ia suaia i le parakalafa e faapea:-**

"(a) Se alauni e tuusaunoa mai i lafoga i le totogi fuapauina e \$8,000 i le tausaga e amata mai i le aso 25 o Novema 1991 e oo mai i ma aofai ai le aso 12 Me 1992, ma i se totogi fuapauina e \$10,000 i tausaga taitasi e mulimuli mai ai."

(c) I le faaofiina i ai ina ua tuanai le fuaiupu 2 le faafuaiupu sou e avea ai o se faafuaiupu (2A):- "(2A) E faaopoopo atu i lona totogi o le Faatonu ma Suetusi Sili o le aiaia i nisi faamanuiaga faaopoopo e pei ona o le a fuafuaina mai i lea taimi i lea taimi e le Kapaneta, ma o aiaiga o le faafuaiupu (3) o lenei fuaiupu o le a tatau ona faaaoga i nisi faamanuiaga e avea ai o se vaega o lona totogi."
