AN ACT to amend the Agricultural Store Corporation Act 1975
[23 July 1991]

BE IT ENACTED by the Legislative Assembly of Western Samoa in Parliament assembled as follows:-

1. Short title—This Act may be cited as the Agricultural Store Corporation Amendment Act 1991 and shall be read together with and deemed part of the Agricultural Store Corporation Act 1975 (hereinafter referred to as the principal Act).

2. Establishment of Corporation—Subsection (2) of section 3 of the principal act is amended by adding the following new paragraph (f):-

“(f) Two other persons who shall be appointed by the Head of State acting on the advice of Cabinet.”

3. Terms of office of appointed members—Section 4 of the principal Act is repealed and the following section is substituted:-

“**4. Terms of office of appointed members**—Every appointed member, whether appointed before or after the commencement of this Act, shall hold office at the pleasure of the Head of State, acting on the advice of Cabinet.”

4. Extraordinary vacancies—Subsection (2) of section 5 of the principal Act is repealed.
