AN ACT to amend the National Provident Fund Act 1972.

BE IT ENACTED by the Legislative Assembly of Western Samoa in Parliament assembled as follows:-

1. **Short title and commencement** - (1) This Act may be cited as the National Provident Fund Amendment Act 1993/1994 and shall be read together with and deemed part of the National Provident Fund Act 1972 (hereinafter referred to as the principal Act).

(2) This Act shall be deemed to have come into force on the 30th day of June 1993.

2. **Interpretation** - Section 2 of the principal Act is amended by inserting in their proper alphabetical positions the following new definitions:-

"Former GSF Contributor" means an employee who ceased to be a member of the Government Superannuation Fund in accordance with the provisions of section 21 of the Government Superannuation Act 1972 (as inserted by the Government Superannuation Amendment Act 1993/1994).

"Former GSF Pension" means a pension which ceased to be payable from the Government Superannuation Fund in accordance with the provisions of section 19 of the Government Superannuation Act 1972 (as inserted by the Government Superannuation Amendment Act 1993/1994).

"GSF Transfer Balance" in respect of a former GSF contributor means the amount determined in accordance with the provisions of section 18 of the Government Superannuation Act 1972." (as inserted by the Government Superannuation Amendment Act 1993/1994).

3. Payment of Contributions - Section 16 of the principal Act is amended by omitting the proviso to subsection (1) and substituting the following:-

"Provided that -

- (a) In respect of an employee engaged in any prescribed employment, the Board notwithstanding any other provisions of this Act may direct the manner in which such contributions shall be calculated and

paid, and the Board may further direct that payment shall be made by some other person on behalf of and to the exclusion of the employer as defined in section 2 of this Act, whereupon such other person shall be deemed to be the employer for the purposes of the next succeeding subsection; and

- (b) In respect of a former GSF contributor for whom a higher rate of contribution was payable under the provisions of subsection (1) of section 5 of the Government Superannuation Act 1972, the employee may elect, in a form approved by the Board, to have the contribution payable in respect of him to be determined as though subsection (1) of section 5 of the Government Superannuation Act 1972 as at 30 June 1993 would have otherwise remained applicable to him, until he -
- (i) Ceases to be an employee of the Government of Western Samoa or any other employer to whom the provisions of subsection (3) of section 3 of the Government Superannuation Act 1972 applied at the 30th day of June 1993; or
 - (ii) Receives a benefit under section 35 of the Act - "whichever is the earlier".

4. Amount standing to credit of member - Section 23 of the principal Act is repealed and the following new section is substituted:-

"23. Amount standing to credit of member - The amount standing to the credit of a member of the Fund for the purposes of sections 35 and 36 of this Act shall be a sum equal to -

- (a) The aggregate of all contributions made in respect of that member excluding where the member is a former GSF contributor any contributions made under the provisions of section 5 of the Government Superannuation Act 1972;
- (b) In respect of a member who is a former GSF contributor, his GSF transfer balance; and
- (c) Subject to subsection (2) of section 25 of this Act, such interest as may have been credited thereon to such member under the provisions of the said subsection."

5. General Reserve Account - Section 26 of the principal Act is amended by omitting paragraph (b) of subsection (3) and substituting the following:-

"(b) Secondly in payment of such amounts to the Pension Reserve Account as may be determined by the Board under the provisions of section 27 of this Act."

6. Residual balances in accounts of former pensioners - Section 27 of the principal Act is repealed and the following new section is substituted:-

"27. Pension Reserve Account -(1) With effect from the 1st day of July 1993 the Board shall establish an account

known as the Pension Reserve Account which shall form part of the Fund and to which shall be credited as at that date -

- (a) The amount transferred from the Government Superannuation Fund in respect of former GSF pensions under the provisions of subsection (3) of section 20 of the Government Superannuation Act 1972;
- (b) The sum of any amounts standing to the credit of the account of each person receiving a pension under the provisions of section 35 of this Act as at that date; and
- (c) An additional amount determined by the Board, after considering the results of the actuarial investigation of the Pension Reserve Account carried out under the provisions of subsection (4) of this section as at the 1st day of July 1993, which would in its opinion enable the Pension Reserve Account to meet its liabilities in respect of pensions payable at that date and such amount shall be transferred from the General Reserve Account under the provisions of subsection (3) of section 26 of this Act.

(2) There shall be credited to the Pension Reserve Account -

- (a) On the date of a member commencing to receive a pension under the provisions of subsection (1) of section 35 of this Act or a dependent spouse of a

member commencing to receive a pension under the provisions of paragraph (c) of subsection (1) of section 35 of this Act, the amount standing to the credit of such member in respect of which the pension is to be paid;

- (b) Any amount determined by the Board, after considering the results of an actuarial investigation of the Pension Reserve Account carried out under the provisions of subsection (4) of this section, which would in its opinion enable the Pension Reserve Account to meet its liabilities and such amount shall be transferred from the General Reserve Account under the provisions of subsection (3) of section 26 of this Act; and
- (c) Interest at such rate and in such manner on the balance in the Pension Reserve Account as the Board may determine.

(3) There shall be debited to the Pension Reserve Account -

- (a) All pensions payable under the provisions of this Act;
- (b) Any amount determined by the Board, after considering the results of an actuarial investigation of the Pension Reserve Account carried out under the provisions of subsection (4) of this section, which in its opinion are not necessary to enable the Pension

Reserve Account to meet its liabilities and such amount shall be transferred to the General Reserve Account;

(c) On the death of a pensioner any amounts due to be paid under the provisions of section 35A or paragraphs (b) and (c) of subsection (5) of section 35 of this Act.

(4) As at the 1st day of July 1993 and at intervals not exceeding three years thereafter the Board shall appoint an actuary to carry out an investigation into the financial condition of the Pension Reserve Account and to report to the Board on the results of such investigation."

7. Former GSF Pensions - The Principal Act is further amended by inserting immediately after section 35 the following new section:-

"**35A. Former GSF Pensions** - Each former GSF pension shall be payable under the same terms and conditions as applied under the provisions of section 10 of the Government Superannuation Act 1972 as at the 30th day of June 1993, provided that the Board in its sole discretion may increase any pension payable under this section or introduce additional benefits in respect of a pension payable under this section for a pensioner or his dependants."

8. GSF members' existing loans - Section 38 of the principal Act is amended by inserting in subsection (2) immediately after the words "from any source" the words "including the

Government Superannuation Fund" and in the same subsection immediately after the words "to any member" the words "including any member of the Government Superannuation Fund."
