Schedule

1991, No. 22

AN ACT to authorise increases in revenue in the revenue derived from certain charges and fees levied under the several Acts named in the Schedule.

BE IT ENACTED by the Legislative Assembly of Western Samoa in Parliament assembled as follows:-

1. **Short Title** - This Act may be cited as the Omnibus Fees and Charges Amendment Act 1991.
2. **Commencement** - This Act shall commence on 1 January 1992.
3. **Amendments** - The several Acts referred in the Schedule are amended in the manner specified underneath the reference to each Act.
