Schedule

1991, No. 21

AN ACT to authorise the issue and application of additional sums of money out of the Treasury Fund to certain services of the year ending with the 30th day of June 1992 and to authorise the reduction of certain sums of money previously appropriated for certain services for that year.

BE IT ENACTED by the Legislative Assembly of Western Samoa in Parliament assembled as follows:-

1. **Short title** - This Act may be cited as the Supplementary Appropriation Act (No. 2) 1991.
2. **Application** - Sections 3 and 4 and the Schedule of this Act relate to the year ending with the 30th day of June 1992 (herein referred to as "the year 1992").
3. **Amendment to Appropriation Act (No. 2) 1991** - The Appropriation Act (No. 2)

1991 is amended by reducing the appropriations authorised pursuant to that Act by the sum of \$4,620,000 by effecting the reduction shown in column 2 of the second part of the Schedule to this Act.

4. **Grant and appropriation of \$12,087,985 out of Treasury Fund -** (1) There may be issued out of the Treasury Fund and applied to the services of the year 1991/92 in addition to the sums appropriated for the year 1991 under the Second Appropriation Act 1991 as amended by section 3 of this Act the sum of \$12,087,985.

(2) The sum authorised to be applied by subsection (1) of this section is hereby appropriated to the services expressed in the votes specified in the first part and in column 3 of the second part of the Schedule to this Act.
