AN ACT to authorise the issue and application of additional sums of money out of the Treasury Fund to certain services of the year ending with the 30th day of June 1993.

BE IT ENACTED by the Legislative Assembly of Western Samoa in Parliament assembled as follows:-

1. Short title- This Act may be cited as the Supplementary Appropriation Act (No.2) 1992/1993.
2. Application- Section 3 and 4 and the Schedule of this Act relate to the year ending with the 30th day of June 1993 (herein referred to as "the year 1993").
3. Amendment to Appropriation Act 1992/1993 - The Appropriation Act 1992/1993 is amended by adding to the appropriations authorised pursuant to that Act the sum of \$3,683,705

as shown at the end of column 2 in the first part of Schedule to this Act and the sum of \$7,271,000 as shown at the end of column 2 in the second part of the Schedule to this Act.

4. **Grant and appropriation of \$10,954,705 out of Treasury Fund-** (1) There may be issued out of the Treasury Fund and applied to the services of the year 1992/1993 in addition to the sums appropriated for the year 1993 under the Appropriation Act 1992/1993 as amended by section 3 of this Act the total sum of \$10,954,705.

(2) The sum authorised to be applied by subsection (1) of this section is hereby appropriated to the services expressed in the votes specified in the first part and the second part of the Schedule to this Act.
