AN ACT to amend the Water Act 1965

BE IT ENACTED by the Legislative Assembly of Western Samoa in Parliament assembled as follows:-

1. Short Title and commencement - (1) This Act may be cited as the Water Amendment Act 1992/1993 and shall be read together with and deemed part of the Water Act 1965 (hereinafter referred to as the principal Act).

(2) This Act shall commence on a date to be appointed by the Head of State acting on the advice of Cabinet, by Order.

2. Interpretation - (1) Section 3 of the principal Act is amended by inserting in their proper alphabetical positions the

following new definitions :-

"Domestic use" does not include use by paying guests:

"Dwelling unit" means a structure specifically constructed or reconstructed solely for residential occupation by a single family whether as a detached house, or as a separate unit in an attached construction or in a block of flats, or in a building of a like nature:

"Government water supply" or "Government supply" means a supply of water which is provided by the Director pursuant to subsection (1) of section 24 of this Act:

"Government water supply district" means a locality served by a Government water supply:

"Ordinary water supply" has the meaning given to it by subsection (3) of section 24 of this Act:

"Potable water" means water which, at its point of delivery into the piped reticulation system, complies with the guideline standards for drinking water quality as recommended by the World Health Organisation:

"Potable water supply" has the meaning set by subsection (2) of section 24 of this Act; and "supply of potable water" has a corresponding meaning."

(2) Section 3 of the principal Act is further amended by

omitting-

- (a) from the definition of "Community" all of the words occurring after the word "waterworks" and substituting the words "other than waterworks forming part of a Government supply".
- (b) the whole of the definition of North Upolu water supply district.

3. Abolition of North Upolu water supply district - (1)

The principal Act is amended by omitting the words "the North Upolu water supply" wherever those words occur, except where they occur in sections 22 and 33 and substituting in each case the words "a Government water supply".

- (2) The First Schedule to the principal Act is repealed.

4. Government water supply - Section 22 of the principal Act is repealed and the following section is substituted:-

" 22. **Government water supply** -(1) The Director may supply water to any premises within the area formerly known as the North Upolu water supply district and to any premises in any other place or places in Western Samoa as the Minister may determine and the supply of such water shall be known as a Government water supply.

(2) The Director may prepare a scheme plan or scheme plans for the construction, extension or enlarging of the water supply for the use of the inhabitants of any part

or parts of Western Samoa, and of shipping in any harbour, and shall submit the scheme plan of the proposed work -

- (a) to the Director General of Health; and
- (b) if the water supply will come from or through or otherwise affect any State forest land, to the Minister of Agriculture, Forests and Fisheries; and
- (c) if the water supply will come from or through or otherwise affect other public land, to the Minister of Lands and Environment.

(3) All parties mentioned in subsection (2) of this section shall endeavour to ensure that the proposed work will not be detrimental to public health and will be in all the circumstances practicable and desirable.

(4) The Director shall not commence any such proposed work until the Minister has notified in writing his approval of the scheme plan therefor."

5. Water rates to be paid - Section 23 of the principal Act is amended by -

- (a) inserting in subsection (1) after the words "the scale set out in" the words "the First Part of";
- (b) repealing the proviso to subsection (2).

6. Types of Government supply - Section 24 of the principal Act is repealed and the following section is

substituted :-

" 24. Types of Government supply - (1) Water from a Government supply is either a potable water supply or an ordinary water supply.

(2) A potable water supply is a Government supply of potable water and includes a Government supply which is ordinarily potable but which has become temporarily polluted as a result of an accident or the happening of an unforeseen event.

(3) An ordinary water supply is a Government supply which is not a potable water supply."

7. Potable water supply to be metered - (1) The heading to section 25 of the principal Act is amended by omitting the word "Extraordinary" and substituting the words "Potable water".

(2) Section 25 of the principal Act is further amended by omitting from subsection (1) the words "extraordinary supply of water" and substituting the words "supply of potable water".

8. Disputing accuracy of meter - Section 26 of the principal Act is amended by:-

(a) omitting from subsection (1) the expression "\$6" and substituting the expression "\$30";

(b) omitting from subsection (1) the words "400 gallons"

and substituting the words "2 cubic metres";

(c) inserting in subsection (2) after the words "4 percent" the words "in excess".

9. Ordinary water rates to be payable quarterly - (1)

Subsection (1) of section 28 of the principal Act is amended by:-

(a) omitting the word "January" where that word first appears and substituting the word "July";

(b) omitting the words "31st day of December" and substituting the words "30th day of June";

(c) omitting the words "on the 1st day of January" where those words last appear and substituting the words "by quarterly instalments on the 1st days of July, October, January and April"

(2) Rates payable in respect of the supply of ordinary water to any premises before the commencement of this Act shall be apportioned and applied down to the date of commencement of this Act pursuant to the provisions of the principal Act as if that principal Act had not been amended.

10. When potable water supply rates payable - (1) Section 29 of the principal Act is amended by omitting from the heading the words "extraordinary water" and substituting the words "potable water supply".

(2) Section 29 of the principal Act is further amended

by repealing subsection (1) and substituting the following:-

"(1) Water rates for a potable water supply which for the time being is unmetered shall become due for payment at the end of each rating year or on the date of installation of a meter whichever first occurs, and in the latter event shall be payable on a proportionate basis."

(3) subsection (2) of section 29 of the principal Act is amended by :-

(a) omitting the word "extraordinary" and substituting the word "potable";

(b) omitting the words "number of gallons" and substituting the words "volume of water".

11. Discount on rates - Section 31 of the principal Act is amended by omitting the expression "25" and substituting the expression "5".

12. Interest on unpaid rates - The principal Act is amended by inserting immediately after section 31 the following new section:-

"31A. Interest on unpaid rates - (1) Where any water rates remain unpaid at the expiry of 30 days from the date upon which such rates were due for payment the Director shall charge interest on such unpaid rates calculated at the rate of 18% per annum from the date upon which such water rates were due for payment down to a date not later

than the date of payment thereof.

(2) Interest charged pursuant to this section shall be added to and form part of the water rates to which that interest relates. "

13. Director may construct waterworks - Paragraph (a) of subsection (1) of section 33 of the principal Act is repealed and the following paragraph is substituted:-

"(a) The inhabitants of any part of Western Samoa and of shipping in any harbour."

14. Director or Committee may supply water - (1) Section 37 of the principal Act is amended by omitting the words "an extraordinary" wherever those words occur and substituting in each case the words "a potable water supply".

(2) Section 37 of the principal Act is further amended by adding a new subsection as follows :-

"(7) Where any application is made for connection or reconnection of any premises to a Government water supply, such application shall be accompanied by a connection fee in accordance with the Second Part of the Second Schedule to this Act, which fee shall be refunded if the Director does not agree to make such connection."

15. Rebate of rates on failure of supply - Section 50 of the

principal Act is amended by omitting the words "water rates are payable annually on a per tap with maximum basis" and substituting the words "ordinary water rates are payable".

16. **Abolition of communities** -Section 52 of the principal Act is repealed and the following section is substituted:-

" **52. Abolition of communities** - Where the Director provides a Government water supply to the inhabitants of any community, the Head of State, acting on the advice of Cabinet, may, by Order, abolish a community and its Water Supply Committee if the whole of the area of the community is included in the Government water supply; and may alter and redefine the boundaries of a community and reconstitute its Water Supply Committee if part only of its area is included in the Government water supply; and in either case may make such further adjustments as may appear to the Head of State, acting on such advice, to be necessary or desirable."

17. **Water supply regulations** -Subsection (1) of section 54 of the principal Act is amended by omitting the words "or to the water supply of any new district created under this Act".

(2) Subsection (2) of section 54 of the principal Act is amended by-

- (a) repealing paragraph (b);
- (b) omitting from paragraph (d) all the words occurring

after the words "water rates" and substituting the words "for the supply of water from a Government supply and altering the fees for connecting or reconnecting a water supply".

18. Penalties - The maximum penalties provided for in the principal Act are amended in accordance with the provisions of the First Schedule to this Act.

19. Rates and exemptions - (1) The Second Schedule to the principal Act is repealed and is replaced by the schedule appearing as the Second Schedule to this Act.

(2) The Fourth Schedule to the principal Act is repealed.

20. Act to bind Government - The principal Act is amended by adding the following new section:-

" 56. **Act to bind Government** - This Act shall bind the Government. "

21. Abolition of Fa'asaleleaga Water Supply District - (1) The Fa'asaleleaga Water Supply District is abolished and its assets and functions by this Act become part of the Government Water Supply.

(2) The Fa'asaleleaga Water Supply Act 1969 is repealed, and water rates in respect of water supplied in the area which

formerly comprised the Fa'asaleleaga Water Supply District shall henceforth be payable pursuant to the principal Act.

22. **Savings and validations** - (1) Nothing in this Act shall operate to extinguish or modify the liability of any person under any of sections 23, 24, 25, 28, and 29 of the principal Act or under section 3 and 4 of the Fa'asaleleaga Water Supply Act 1969 to pay water rates to the Director pursuant to any of those sections as they appeared prior to the commencement of this Act.

(2) Notwithstanding anything to the contrary in the principal Act or any other Act where the Director has at any time before the commencement of this Act supplied water to any premises which were not connected to the North Upolu water supply, and has charged or imposed rates for that supply, those rates are deemed to have been lawfully charged or imposed and the provisions of parts IV and V of the principal Act with the necessary modifications shall be deemed always to have applied with respect to every such supply.

(3) Every supply of water which at the commencement of this Act is provided by the Director, is lawfully a Government water supply for the purposes of the principal Act whether or not the provisions of section 22 of the principal Act have been complied with.

(4) Notwithstanding the repeal of the Fa'asaleleaga Water Supply Act 1969, the amendments made to the Schedule of the

District Wharf Regulations (Mulifanua and Salelologa) 1959 by
that Act shall continue in force as if that Act had not been
repealed.

First Part

Water Rates

(1) Where unmetered water is supplied to any premises the rate shall be:-

(a) In respect of water supplied to a dwelling unit for domestic use only, \$48 per annum for each dwelling unit.

(b) In respect of water supplied to premises comprising or including a cattle farm, piggery, poultry farm or small crop development, \$96 per annum for each connection.

(c) In respect of water supplied to any dwelling unit where paragraph (a) hereof does not apply or to any other premises where paragraph (b) hereof does not apply, \$192 for each connection.

(2) Where metered water is supplied to any premises the rate shall be:-

(a) In respect of water supplied to a dwelling unit for domestic use only or to premises of a kind described in clause (3) hereof -

- (i) For the first 2.5 cubic meters per day of water consumption - 5 sene per cubic metre;
- (ii) For the second 2.5 cubic meters per day of water consumption - 10 sene per cubic metre;
- (iii) For water consumption in excess of 5 cubic metres per day - 15 sene per cubic metre of such excess,

in each case with a minimum charge of \$48 per annum for each dwelling unit, and a minimum charge of \$192 per connection for other premises.

(b) In respect of water supplied to premises comprising or including a cattle farm, piggery, poultry farm or small crop development -

- (i) For the first 2.5 cubic meters per day of water consumption - 10 sene per cubic metre;
- (ii) For the second 2.5 cubic meters per day of water consumption - 15 sene per cubic metre;
- (iii) For water consumption in excess of 5 cubic metres per day - 20 sene per cubic metre of such excess,

in each case with a minimum charge of \$96 per annum per connection.

(c) In respect of water supplied to any dwelling unit where paragraph (a) hereof does not apply or to any other premises where neither paragraphs (a) or (b) applies -

- (i) For the first 2.5 cubic metres per day of water consumption - 20 sene per cubic metre;
- (ii) For the next 5 cubic metres per day of water consumption - 25 sene per cubic metre;
- (iii) For water consumption in excess of 7.5 cubic metres per day - 30 sene per cubic metre of such excess,

in each case with a minimum charge of \$192 per annum for each connection."

(3) The premises to which clause (2)(a) applies are:-

- (a) Premises used as a day care centre;
- (b) Premises used as a school or kindergarten;
- (c) Premises used as a College or University;
- (d) Premises used as hospital;
- (e) Premises used as a home for the elderly;
- (f) Premises used as a convent;
- (g) Premises used as a Seminary.

(4) Where water is supplied and the supply falls partly into one rating category and partly into another or others the rate

to be applied to the whole of the water supplied shall be in accordance with the highest of those categories.

In addition where the line is required to cross a bitumen road there shall be paid in respect of premises within the Apia urban area the further sum of \$500 and for premises outside the Apia urban area the further sum of \$250.

Reconnection fee

For reconnecting any water supply after disconnection for non payment of water rates the fee shall be \$70.00.
