**ORDER OF PROHIBITED EXPORTS
(SEA CUCUMBER) 2010 - SECTION 73,
CUSTOMS ACT 1977**

I, TUI ATUA TUPUA TAMASESE EFI, Head of State of the Independent State of Samoa, acting on the advice of Cabinet and pursuant to section 73 of the Customs Act 1977, **ORDER** that:

1. It is unlawful to export a sea cucumber of any species.
2. This Order comes into effect on the date it is made.
